## RULES FOR VENDORS OF STRAWBERRY FESTIVAL 2024

*All Vendors must follow all the rules of the event, or they will not be invited back to future events/festivals.*

1. All Vendors must leave their area as they found it. Please, do not leave trash, tents, etc. behind. If anything is left behind, a disposal fee of \$35.00 will not be returned.
2. Vendors are only allowed to sell what is approved to sell by Ottawa Farms and what is clearly listed on your application. If an item is to be added after the application has been submitted, you can send an e-mail to [ottawafarms@gmail.com](mailto:ottawafarms@gmail.com) for additional approval.
3. All vendors are to be set up and all vehicles **MUST** be out of the festival area by *8:30 am on Saturday and 12:30pm on Sunday*.
4. Friday set up is allowed for all vendors. We do not provide security and will not be responsible for any loss, theft or damages of any kind.
5. **No** vendors are to park inside the festival area during the festival. Vehicles must be moved by 30minutes before start time. No Exceptions!
6. All vendors **MUST** stay OPEN until 6:00pm. Vendor set ups cannot be broken down until 6pm each day.
7. If a vendor arrives after a half an hour to start time, they will not be allowed to drive in the festival area. NO REFUNDS. NO EXCEPTIONS. PLAN AHEAD. **ALL Vendors must be set up and ready to start 30 minutes before the start of the festival.**
8. Applications and vendor fees are due no later than **April 1, 2024**.
9. The festival is rain or shine. Only if weather is a threat (lightning) will the festival be shut down or cancelled. Refunds will not be given to vendors who do not show up.
10. All vendors that provide a product or service that requires a customer to be touched or have something ingested (food) must provide a copy of Liability Insurance and must be included with your application.
